Pre-applications are available at the Middletown Housing Authority or by utilizing the form below. Applicants may also mail in the same information on a blank sheet of paper. Only one pre-application per family. Any family submitting more than one pre-application will be disqualified. **ONLY ONE PRE-APPLICATION PER ENVELOPE.** The pre-application must contain accurate and complete information and must be written in a **legible fashion**. Submission of false or misrepresented facts may result in loss of eligibility to participate in this program. Any pre-application that is **not legible** will be disqualified.

Only Pre-applications postmarked **September 11, 2019 through September 12, 2019 and received by September 23, 2019** will be accepted. 800 Pre-applications will be drawn at random on October 25, 2019. **Applicants will be notified only if they are selected.** If you have not received notification by November 15, 2019 then you have not been selected for the Wait List. No walk in, phone, fax, email or voice mail pre-applications will be accepted.
